Who We Are

Southwest Behavioral & Health Services (SB&H) was established in 1969 as a federally funded program under a partnership known as St. Luke's - Jane Wayland Community Mental Health Center.

Incorporated in 1974 as a 501(c)3 non-profit, the organization continued to grow as Phoenix South Community Mental Health Center when federal funding ceased in 1979.

After over 40 years of community service, Southwest Behavioral & Health Services continues to prosper.

Our agency employs over 900 full-time staff and an additional workforce available from part-time positions and contracts. Staff and volunteers reflect the cultural diversity of the community. SB&H is governed by a Board of Directors comprised of approximately 15 community volunteers. Our service area includes the Phoenix metropolitan area, rural Maricopa County, Gila, Mohave, Coconino and Yavapai Counties.

Historically, SB&H has assumed a leadership role in development and delivery of services in the areas of housing, residential care, prevention services, outpatient services to children, incarcerated persons and dually diagnosed adults (SMI/SA).

Over the past several years, Southwest Behavioral & Health Services has experienced rapid growth of its behavioral health programs. SB&H has developed a reputation as an innovative leader in behavioral health. Our services are evidence-based and include treatment of co-occurring disorders, the FAST model in prevention services, the Arizona Treatment Initiative for children and families and the Recovery Model for persons with serious mental illness.

Southwest Behavioral & Health Services is contracted through Mercy Maricopa Integrated Care (MMIC), the Regional Behavioral Health Authority for Maricopa County; and Health Choice Integrated Care (HCIC), the Regional Behavioral Health Authority for Mohave, Coconino, Apache, Navajo, Gila and Yavapai counties. Funds for services are provided through a contract with the Arizona Department of Health Services/Division of Behavioral Health Services and AHCCCS.

Erickson Foundation Collaboration

The SB&H Training Institute works in collaboration with Argosy University, Midwestern University and Arizona State University to provide ongoing training for practicum students in the Clinical Psychology Doctoral Program. Our students are placed in various programs but primarily placed at the Erickson Outpatient site. The Erickson Practicum students provide outpatient services to adult GMH and substance abuse clients.
